4.1 DESCRIPTION OF FIRST AID MEASURES

In case of eye contact Immediately flush eyes with plenty of water, occasionally lifting the upper and lower eyelids. Check and

remove any contact lenses, if present and easy to do. Continue rinsing for at least 10 minutes. Get medical

attention if irritation occurs/persists.

In case of skin contact Discontinue use of product. Wash contaminated clothing and shoes. Continue to rinse for at least 10 minutes.

Get medical attention if irritation occurs/persists. Wash clothing and shoes before reuse.

If swallowed Wash out mouth with water. Remove dentures if any. Remove victim to fresh air and keep at rest in a position

comfortable for breathing. If material has been swallowed and the exposed person is conscious, give small quantities of water to drink. Stop is the exposed person feels sick as vomiting may be dangerous. Do not induce vomiting unless directed to do so medical personnel. If vomiting occurs, the head should be kept low

so that vomit does not enter the lungs. Never give anything by mouth to an unconscious person. If unconscious, place in recovery position and get medical attention immediately. 6.3 METHODS AND MATERIAL FOR CONTAINMENT AND CLEANING UP

Small spill Stop leak if without risk. Move containers from spill area. Use spark-proof tools and explosion-proof

equipment. Dilute with water and mop up if water-soluble. Alternatively, or if water-insoluble, absorb with an inert dry material and place in an appropriate waste disposal container. Dispose of via a licensed waste

disposal contractor.

Large spill Stop leak if without risk. Move containers from spill area. Use spark-proof tools and explosion-proof

equipment. Approach release from upwind. Prevent entry into sewers, water courses, basements, or confined areas. Wash spillages into an effluent treatment plant or proceed as follows. Contain and collect spillage with non-combustible, absorbent material (e.g., sand, earth, vermiculite, or diatomaceous earth) and place in container for disposal according to local regulations. Dispose of via a licensed waster disposal contractor.


